Water Act Approval

The Environmental Appeals Board is rescheduling the October 6-7, 2020 hearing via video conference to a later date. The Board will hear submissions with respect to the decision of Alberta Environment and Parks to issue *Water Act* Approval No. 00419723-00-00 to the Town of High River. The Approval authorizes the construction and placement of a berm, and swale within the flood plain of the Highwood River resulting in the permanent alteration of the flow, direction of flow and water levels, changing the location of water for drainage purposes, and maintaining, removing, or disturbing ground, vegetation or other material in or on any land, water or waterbody. The locations of the activities are Sections 35-018-29-W4M and S½-01-019-29-W4M in the Town of High River.

About the Board

The Environmental Appeals Board is an independent quasi-judicial body that hears appeals of certain decisions made by Alberta Environment and Parks.

Interventions

Any person, other than the parties, who wishes to make a representation before the Board on these appeals must submit a request in writing by fax or by e-mail to the Board at the fax number or e-mail address set out below. The deadline for intervenor applications has been extended from September 18, 2020 to October 19, 2020. It is your responsibility to ensure that your request is received by the Board by October 19, 2020. Such a request shall (a) contain the name, address, e-mail, and telephone and fax numbers of the person submitting the request, (b) indicate whether the person submitting the request intends to be represented by a lawyer or agent and, if so, the name of the lawyer or agent, (c) contain a summary of the nature of the person's interest in this appeal, and (d) be signed by the person submitting the request. Applications will only be considered if the information will assist the Board in making its decision, and will not duplicate the information provided by the parties. After October 19, 2020, the Board will, in its discretion, determine if other persons may make representations, and the manner in which they can be made. Since the hearing is being held via video conference, it will not be open to the public for viewing. You may request a copy of the audio recording.

The information requested is necessary to allow the Environmental Appeals Board to perform its function. The information is collected under the authority of the *Freedom of Information and Protection of Privacy Act*, section 33(c). Section 33(c) provides that personal information may only be collected if that information relates directly to and is necessary for the processing of this appeal. The information you provide will be considered a public record.
