The Environmental Appeals Board will conduct a hearing on October 10, 2019, commencing at 8:30 am in the conference room, 2nd Floor Centrium Place Bldg., 332-6 Avenue SW, Calgary.

The Board will hear submissions with respect to the decision of Alberta Environment and Parks to issue Enforcement Order No. WA-EO-2018/08-SSR under the Water Act, to Zaia Abraham and Romy Tittel requiring them to cease using a water well on their property located at #12 Elbow River Road, in the Elbow River Estates, in Rocky View County, and legally described as Lot 68, Plan 9010544.

The Environmental Appeals Board is a separate and independent body that reviews certain decisions made by Alberta Environment and Parks. The Board is composed of environmental experts from a variety of disciplines.

Any person, other than the parties, who wishes to make a representation before the Board on this appeal must submit a request by fax or by e-mail to the Board. The request must be received by the Board on or before September 17, 2019. It is the applicant's responsibility to ensure that the request has been received. The request shall (a) contain the name, address, e-mail, and telephone and fax numbers of the person submitting the request, (b) indicate whether the person

submitting the request intends to be represented by a lawyer or agent and, if so, the name of the lawyer or agent, and (c) contain a summary of the nature of the person's interest in this appeal. Applications will only be considered if the information will assist the Board in making its decision, and will not duplicate the information provided by the parties. After September 17, 2019, the Board will determine if other persons may make representations and the manner in which they can be made. Once the Board makes a decision on any intervenor applications, the hearing will be open to the public for viewing only.

The information requested is necessary to allow the Environmental Appeals Board to perform its function. The information is collected under the authority of the *Freedom of Information and Protection of Privacy Act*, section 33(c). Section 33(c) provides that personal information may only be collected if that information relates directly to and is necessary for the processing of this appeal. The information you provide will be considered a public record.
