Environmental Appeals Board hearing schedule

The Environmental Appeals Board will conduct a hearing on July 23-27, 2018 and August 27-31, 2018, commencing at 8:30 am at the Board's office.

The Environmental Appeals Board will hold a hearing with respect to the decisions of Alberta Environment and Parks to issue to Cherokee Canada Inc., 1510837 Alberta Ltd., and Domtar Inc. Enforcement Order Nos. EPEA-EO-2016/03-RDNSR and Amendment No. 1, EPEA-EO-2018/02-RDNSR, EPEA-EO-2018/03-RDNSR and EPEA-EO-2018/04-RDNSR. The Orders are for a site operated as a wood processing and treatment plant from 1924 to 1987.

The site is located at 44 Street and 127 Avenue in the City of Edmonton and is legally described as Plan 1321679, Block 1, Lot 1 (Parcel Y), Plan 1012AY, Block C, prior to its subdivision (Parcel C), Plan 4677CL, Parcel X (Parcel X), and SW and NW 18-53-23-W4M (Greenbelt). The site was previously owned by Domtar Inc.

The Environmental Appeals Board is a separate and independent body that reviews certain decisions made by Alberta Environment and Parks. The Board is composed of environmental experts from a variety of disciplines.

Any person, other than the parties, who wishes to make a representation before the Board on these appeals must submit a request by fax or by e-mail to the Board. The request must be received by the Board no later than 4:30 pm on June 11, 2018. It is the applicant's responsibility to ensure that the request has been received. The request shall (a) contain the name, address, e-mail, and telephone and fax numbers of the person submitting the request, (b) indicate whether the person submitting the request intends to be represented by a lawyer or agent and, if so, the name of the lawyer or agent, and (c) contain a summary of the nature of the person's interest in these appeals. Applications will only be considered if the information will assist the Board in making its decision, and will not duplicate the information provided by the parties. After 4:30 pm on June 11, 2018, the Board will determine if other persons may make representations and the manner in which they can be made. Once the Board makes a decision on any intervenor applications, the hearing will be open to the public for viewing only.

Please contact the Board for further information regarding this appeal.

The information requested is necessary to allow the Environmental Appeals Board to perform its function. The information is collected under the authority of the *Freedom of Information and Protection of Privacy Act*, section 33(c). Section 33(c) provides that personal information may only be collected if that information relates directly to and is necessary for the processing of these appeals. The information you provide will be considered a public record.
