Environmental Appeals Board hearing schedule

December 19, 2016 Media inquiries

The Environmental Appeals Board will be conducting a hearing via written submissions only with respect to appeals filed in relation to Alberta Environment and Parks' decision to issue Administrative Penalty No. 15/03-AP-RDNSR-15/03 to M. Pidherney's Trucking Ltd. and 1598768 Alberta Ltd. in the amount of \$224,542.00 for allegedly operating a pit exceeding 5 hectares without authorization and failing to report any contravention of the Code of Practice for pits. The pit is located at SW-5-40-9-W5M in Clearwater County.

The Environmental Appeals Board is a separate and independent body that reviews certain decisions made by Alberta Environment and Parks. The Board is composed of environmental experts from a variety of disciplines.

Any person, other than the parties, who wishes to make a representation before the Board on these appeals must submit a request by fax or by e-mail to the Board. The request must be received by the Board on or before January 6, 2017. It is the applicant's responsibility to ensure the request has been received. Such a request shall (a) contain the name, address, e-mail, and

telephone and fax numbers of the person submitting the request, (b) indicate whether the person submitting the request intends to be represented by a lawyer or agent and, if so, the name of the lawyer or agent, and (c) contain a summary of the nature of the person's interest in these appeals. Applications will only be considered if the information will assist the Board in making its decision, and will not duplicate the information provided by the parties. After January 6, 2017, the Board will determine if other persons may make representations and the manner in which they can be made.

Copies of material filed with the Board respecting these appeals are available for viewing at the Rocky Mountain House Public Library, 4922-52 Street, Rocky Mountain House, Alberta, during its normal operating hours, or by appointment at the office of the Environmental Appeals Board in Edmonton.

The information requested is necessary to allow the Environmental Appeals Board to perform its function. The information is collected under the authority of the *Freedom of Information and Protection of Privacy Act*, section 33(c). Section 33(c) provides that personal information may only be collected if that information relates directly to and is necessary for the processing of these appeals. The information you provide will be considered a public record.
